Steps for Use

Care for your skin after ensuring that your hair does not fall onto your face



To wear the mask properly

Wear the mask on your face.




How to apply the gel



*Use about one pearl-sized drop of the included skincare product for each electrode.

*Examples of incorrect wearing




There are gaps, and the electrodes are not touching

and your cheek or chin

and your forehead

If you have a small face Please use a headband or adjust with a hair tie.



How to wear the mask



- Attach by pulling up from under the chin to the O section.
- Attach in a way there are no large gaps between the mask and your face.

If the cheek or chin sections (parts) lift up, the electrodes near the jaw muscles will not be in contact with the skin





It is fine even if the mask fits closely to your mouth.



Steps for Use

Turn on the device

Press and hold the Power/LED Mode button for about two seconds.

Power/LED Mode button



Select the LED Mode and the **EMS** level

Power/LED Mode button EMS level button



Turn off the device

The device will automatically turn off about 10 minutes after it has been turned on.

Precautions

Handle with care after use.

After use, wipe off any gel remaining on the electrodes and allow them to dry completely.

Do not leave the mask in places where it is not easily visible. If left in such places, you may not notice it and accidentally step on it, which may cause device malfunction.

Do not apply excessive force to the mask.

Do not apply excessive force to the mask, such as stepping on it, hitting it, or forcibly bending it.

Failure to comply may cause device malfunction.

• Do not place the mask in ways that put a strain on it.

The product will last longer if you store it folded with the controller on top.



 Ensure that the ambient temperature of the usage is properly maintained.



The device may not correspond effectively to the ambient temperature of a new location immediately after moving to the new location.

Excessive force, including bending, pulling strongly, stepping on, or striking the mask, may cause damage or malfunction.

 Do not press the device too hard and do not use it continuously.

Pressing the device stronger than necessary or using it continuously may damage the skin.

 Do not allow the device to come into contact with another beauty device or electronic appliance while the power is on.

!\ CAUTION (Use and storage)

 Use only Level 1 upon the first use and until you are accustomed to using the device. Even if you do not feel any stimulation, make only small adjustments to the intensity level. Use the device at an intensity level that suits you.

Make only gradual adjustments to the intensity level. Failure to comply may cause accidents or injuries.

 Always check for any signs of irritation on your skin during treatment.

If you experience any pain, fatigue, or skin abnormalities during use, stop using the device immediately.



If the device does not agree with your skin, stop using immediately. If symptoms persist the following day and beyond, consult a physician.

 If you are currently undergoing dental treatment or have teeth fillings, choose a lower intensity level and apply the device on a different area.

You may feel strong irritation or discomfort due to EMS on your cheeks or chin. If you feel strong discomfort, consult a physician.

 Avoid using the device on the same area for longer than 10 minutes.

When using the device on the same area again, be sure to leave an interval of 24 hours or more between treatments. Excessive use may damage the skin. The above is for reference only. Please observe your skin condition and use the device accordingly.



Must Comply

! WARNING (The power supply)

• Use only with a 5 V DC USB power supply. Make sure the plug is fully inserted into the power outlet.

Failure to comply may cause a fire, electric shock. or device malfunction



- If any problem occurs, turn off the power immediately.
- Always use the dedicated USB charging cable.

Failure to comply may cause electric shock, short circuit, or a fire.



WARNING (The power supply)


The device will automatically switch off approx. 10 minutes after it has been turned on.

Mode/Level memory function

The device remembers the LED Mode and EMS level settings and returns to the same settings the next time it is switched on.

Before Use

Charge the Device



- Fully charge the battery before using the device for the first time after purchasing.
- When using the device for the first time or when the device has not been used for an extended period of time, it is possible that you will be able to use the device for a short time only, even with a full charge. In such a case, charge the controllers again before using it.
- Use only the included USB charging cable.
- Please check the current rating indicated on the AC adapter (commercially available). Those with a rating of less than 2 A may not be able to recharge the device.

Charging	The EMS level / Charging / Remaining battery level indicators for Levels 1–3 light up in sequence.
When charging is complete	The EMS level / Charging / Remaining battery level indicators for Levels 1—3 light up for 5 seconds then turn off.

How to check battery level

You can check the remaining battery level by the blinking of Levels 1–3 of the EMS level / Charging /Remaining battery level indicators after powering on and the LED Mode lamp


CAUTION

When you have not used the device for a long period of time, check to see that it is functioning normally before restarting
use. Failure to comply may cause accidents or malfunction.

Pretesting on the skin

When using the device or the recommended skincare product for the first time, always perform a skin compatibility test to help prevent irritation or other skin problems.

- Wash the inner side of your upper arm with a soap, then wipe dry with a towel
- Apply oil-free gel on washed skin and hold the controller on your upper arm. Make sure all three lower electrodes on either the left or right are in contact with your skin and select EMS Level 1 with your other hand, then use the device for approx. 3 minutes
 - For how to use, refer to the section "How to apply treatment" on page 16.



- Wipe off the gel and check that your skin shows no irregularities
 - Use the device only if you experience no skin irregularities (such as redness or a burning sensation) within 24 hours.

CAUTION

- If you experience a rash, redness, itching, stinging, or other irritation at the tested part, stop the test immediately and wash
 the area thoroughly.
- Always check for any signs of irritation on your skin during treatment. If the device does not agree your skin, stop using
 immediately.


How to Use

Preparation



Wash your face and apply the included skincare product to the electrode parts of the device

*If you use the device on your skin when it is dry, it may be difficult for you to feel the EMS.





Electrodes

Care for your skin with skincare products.

- If you use your own skincare products, we recommend thick products.
- If your hair is long, we recommend tying it up.
- Cannot be used over a facial mask.


Do not use oil-based skincare products, such as beauty oils or oil serums. It may cause deterioration of the mask.

CAUTION

Refrain from applying flash treatments without first removing foundation and other makeup products that have been
applied to the skin. Using the device without removing makeup may cause skin problems.

Wear the Blue Green Mask.

1 Fit the mask to your face



- First, align the chin line of the mask, then adjust and align it to the eye area.
- Make sure that no hair is caught in the mask.

Verify that the mask is firmly attached using a mirror



- Lay strap [2] on top of strap [1] and fasten while making adjustments so that the mask fits closely.
- Be careful not to fasten the straps too tightly.
- It is fine even if the mask fits closely to your mouth.

Tips


If the mask is too large, tying your hair at the back
of your head will help keep the face mask in place.
 If the mask is too small, you can use your hand to
hold it in place without having to fasten the band.

<When using with EMS on>
Even if the mask does not fit perfectly
and appears to be loose, as long as the
section with all electrodes is in firm
contact with your skin, you can
proceed with the treatment.

<When using with EMS off>
Even if the mask does not fit perfectly and appears to be loose, as long as the section with the LED surface is in contact with your skin, you can proceed with the treatment.


How to apply treatment

1 Turn on the device



Press and hold the Power/LED Mode button to turn on the power. After LED Mode lamp ⇒ EMS level / Charging / Remaining battery level indicators 1–6 light up in sequence, levels 1–3 of the EMS level / Charging / Remaining battery level indicators flash three times according to the remaining battery level (p. 14).

2 Choose the LED Mode (color)



- Short press the Power/LED Mode button to switch the LED Mode (color).
- There are two colors for mode (color): GREEN and RED.
- The selected LED Mode (color) can be confirmed with the LED Mode lamp.

CAUTION

- Operate the controller while looking in a mirror.
- Refrain from using the device continuously for more than 10 minutes. Failure to comply may cause skin problems.
- If the light feels too bright during treatment, adjust the position of the mask or how the band is fastened or continue treatment with your eyes closed. Failure to comply may cause injury to your eyes or skin.

3

Select EMS intensity level



- Short press the EMS level button to switch between levels 0-6.
- Long press makes a "beep" buzzer sound, and the EMS level becomes 0 (Level 0 does not output EMS).
- You can check level switching with the EMS level / Charging / Remaining battery level indicators.




Turn off the device

- The device will automatically turn off approx. 10 minutes after being powered on.
- If you wish to stop mid-treatment, long-press the Power/LED
 Mode button on the controller.

*After each use, refer to "After Treatment" (page 20) and remove the remaining sebum, skincare product, and other particles that have adhered to the device.

Failing to remove them may cause device malfunction or skin problems.



After Treatment

How to Clean

Clean the mask after each use.

- Wipe off any dirt using a well-wrung soft cloth or similar materials
 - If stubborn dirt remains, gently wipe with a cloth dampened with diluted neutral detergent.
 - Do not leave the device with remaining sebum or skincare product on it.
- 2 Dry the device in a location that is well ventilated
 - Always turn off the device before cleaning.
 Failure to comply may cause electric shock, short circuit, or fire.

CAUTION

- Do not wash with water.
 This device is not waterproof.
 Failure to comply may cause device malfunction.
- Do not use alkaline cleaners, alcohol, thinner, benzene, or nail polish remover when wiping.





Storing the Device

- Store the device in a clean, well-ventilated place out of the reach of children.
- Remove the USB charging cable from the controller when not in use for a long period of time.
- Do not leave the device in hot or humid places, such as near open flames, in direct sunlight, or in a bathroom.

Maintenance and Inspections

- 🎈 If you have not used the device for an extended period, inspect it carefully and check that the device works properly and safely before use.
- If the device is malfunctioning, go to 'Troubleshooting' (page 21~22) and try to identify the problem before arranging to have the device repaired. If the problem persists, contact your local distributor.
- If the device malfunctions or appears damaged, please contact your local distributor.

The device does not turn on	 Press and hold the Power/LED Mode button for about two seconds (page 18). The battery may be depleted. Charge the battery (page 14).
The device only operates for a few minutes	 The device will automatically turn off approx. 10 minutes after being powered on. The battery level is low. Charge the battery (page 14). The battery may have reached the end of its life.
even after charging	• The battery may not be charging properly. Check that charging has started by seeing whether the EMS level / charging / remaining battery indicators are lit or flashing.

Additional Information

Troubleshooting Symptom	If you notice an abnormality during use, check for the following symptoms. Possible causes and solutions
The LED Mode lamp flashes during operation	The battery level is low. Charge the battery (page 14).
The device does not start charging	 Make sure the AC adapter (commercially available) and USB charging cable are properly connected (page 14). Check the current rating indicated on the AC adapter (commercially available). Adapters with a rating lower than 2 A may not be able to charge the device.
EMS feels too strong (tingling or painful)	 The EMS level may be set too high. Please lower the level. Always start at level 1 when using the device for the first time.
EMS feels weak (no sensation)	The EMS level may be set too low. Please increase the level.
No changes in EMS intensity are felt / Tingling or pain is felt even after adjusting the EMS level	Your skin may be too dry.Apply lotion, gel, water, or similar products to moisturize the skin.
EMS sensation varies by treatment area	 Wipe off any dirt on the electrodes. The electrodes are not properly in contact with the skin. Ensure the mask is worn correctly. The battery level is low. Charge the device (page 14).
An electronic sound is heard during treatment	 Depending on muscle mass, some areas may be less sensitive to EMS. This is a normal operating sound and does not indicate a malfunction.

Frequently Asked Questions

What is the recommended duration and frequency of use?

The device can be used every day. However, as a general guide, use it up to 10 minutes per session, once per day.

*The device will automatically switch off approx. 10 minutes after it has been turned on.

*The above information is a guideline only. Please check your skin condition while using the device.

*Always check for any signs of irritation on your skin during treatment.

If the device does not agree your skin, stop using immediately.

Q Can I use the device in the bathroom?

A Do not use the device in the bathroom. This device is not waterproof.

Can I use the device while sleeping?

A Do not use the device while sleeping.

Can I use the device on dry skin?

It can be used when the EMS level is set to 0.

When using EMS on dry skin, it may be difficult to feel the EMS stimulation.

If the EMS feels weak, please moisten your skin using the included skincare product before use.

Can I use the device over a facial mask?

A Not recommended. The LED and EMS effects do not work properly.

My skin has developed a rash, inflammation, or itchiness

This may be caused by stimulation from heat, light, or EMS. If the symptoms persist the following day or beyond, consult a physician.

Q I am concerned about the smell of the mask.

A characteristic odor from the silicone rubber may be noticeable, but this is not abnormal.

Q I feel some discomfort or fatigue.

A This may be caused by stimulation from heat, light, or EMS.

Stop using the device until the discomfort in your face subsides.

Q My teeth hurt when I use the device.

- The pressure of the mask or EMS may cause tooth pain.

 A lf you feel discomfort, consult a physician.
- Can I use the device immediately after suntanning?
- A Using the device immediately after suntanning may cause inflammation. If any skin problems occur, stop using the device immediately and consult a physician.
- Q My skin has developed redness.
- The pressure from the mask may cause temporary redness.

 If the redness persists the following day, consult a physician.

The mask leaves a mark on my face.

The mask is made of stretchable silicone. Depending on your skin condition, it may leave temporary marks. However, there is no need for concern, as the marks will fade over time.

Is there a possibility that

makeup color will transfer
to the mask?

Yes, color transfer may occur. Please remove makeup before using the device.


